Weddings and Social Event FAQs

1. How many guests (including the wedding party) are allowed?

Maximum capacity for a wedding in the Vista Ballroom is 100 guests. All guests have to maintain a social distance of 2 meters with a maximum of 8 guests per table.

2. How many guests are allowed at Social events?

Maximum capacity for a social event is 100 guests. All guests must maintain a social distance of 2 meters. Each table has a maximum of 8 guests per table. Each guests can only consume a maximum of 2 cocktails per table. All tables must be 2 meters apart with a minimum distance of 1.5 meters between chairs.

3. Are performers / live entertainment permitted?

Yes, performers, live entertainment and event hosts are permitted. Performers and artists can remove their mask during their performance only if they can maintain at least 4 meters social distance. Movement or interaction between performers and the audience is not permitted and performers / artists / entertainers should stay in their designated space. It is encouraged to shorten the duration of the performances. All performers must be fully vaccinated.

4. Are DJs permitted?

Yes, but DJs must wear a mask and gloves at all times and must be fully vaccinated.

5. Is there a limit on the number of entertainments / performers?

No, there is no limit but all performers and entertainers must maintain a social distance of 2 meters.

6. Are you allowed to dance?

No, dancefloor is not permitted for guests, only for performers and event host.

7. Is social distancing mandatory?

Yes, guests and staff have to maintain a social distance of 2 meters.

8. Do masks need to be worn throughout the whole day?

All hospitality staff, photographer, organiser, etc must wear a mask and gloves throughout the whole event. Guests are permitted to wear a mask, however once seated at their table the mask may be removed.

9. Are buffets permitted?

Yes, buffets are permitted as long as all guests maintain a social distance of 2 meters. Self- service is not permitted, food will be served by the chef or member of the team.

10. Is there a bar or table service only?

Drinks are served via table service only.

11. Am I allowed a photographer or videographer?

Yes, but photographers and videographers must maintain social distancing and wear a mask while moving around.

12. Are third party caterers permitted?

No, third party caterers are not permitted.

13. Are tea and coffee stations permitted?

Yes, table service only.

14. Will there be a cloakroom for personal belongings?

Yes, guests have to place their belongings into the designated areas, personal belongings should not be handled by staff.

15. Can I use a florist / other third-party supplier?

Yes, as long as the supplier is following all guidelines and regulations and have been approved by the venue.

16. Are hairdressers, makeup artists, henna artists permitted?

Yes, everyone has to maintain a social distance of 2 meters. All hairdressers, makeup and henna artists must sanitize all equipment after each use along with chair sterilization.

17. Is valet parking available?

Yes, valet parking is available.

Additional Points:

- Guests and staff must be fully vaccinated.
- The venue will be thoroughly sterilized pre and post event.
- Hand sanitiser is available at various touch points.
- Restrooms are cleaned and sterlised every hour.
- Additional staff / security will be placed to ensure all guests maintain social distancing.
- All events will have a one-way system in place with separate entrance and exit.
